Your Role for Go-Live

Your role is vital as we prepare for Workday to go live. **Prepare for blackouts:**

Jan. 13 begins the blackout period for some recruiting functions. As much as

- possible, you should refrain from creating new jobs, unfreezing jobs and creating or making changes to requisitions. We will limit the posting of jobs in Talent Central-SuccessFactors during this period, and we also need to minimize the number of requisitions to keep the dual processing period as short as possible. Requisitions that were created in Talent Central-SuccessFactors will remain there through the hiring process and will need to be created in Workday at the time of hiring. Once we are live on Jan. 27, all new requisitions will be created in Workday.

 Any job requisitions approved by Jan. 20 will be worked on by the Talent
- Acquisition team until completion in Talent Central-SuccessFactors. Between Jan. 20 and Jan. 26, submission of new job requisitions will be restricted as we prepare for the Workday Recruiting cutover. Additionally, any pending requisition(s) in Workday that are not approved by Jan. 20 will be cancelled and must be recreated once Workday Recruiting goes live on Jan. 27.

 It is mandatory that you complete and submit your payroll by Monday,
- Jan. 20 at 7:00 p.m. CT. There will be no exceptions to this deadline.
 From Jan. 21 at 7:00 p.m. until Workday goes live, there will be a system-wide
- blackout for all functions in ADP EV5.
 From Jan. 23 at 5:00 p.m. CT until Jan. 27 there will be a blackout for all
